RELEASE AGREEMENT AND COVENANT NOT TO SUE

This release and covenant not to sue is executed and delivered by the undersigned volunteer ("volunteer"), at Montgomery County, Texas to and in favor of the Humane Society of Montgomery County, Inc., A Texas Non-Profit Corporation ("Humane Society of Montgomery County").

Humane Society of Montgomery County operates a non-profit corporation and organization for the prevention of cruelty to animals and related purposes.

The undersigned volunteer wishes to perform services on a voluntary basis for and/or at the facilities and animal shelter of and/or operated by the Humane Society of Montgomery County, located at 1016 East Dallas, Conroe, Texas, and elsewhere, particularly n Montgomery County, Texas.

The undersigned volunteer, in consideration of the premises and to be allowed to perform such services for and/or at the facilities of the Humane Society of Montgomery County, and elsewhere, promises, agrees and covenants, as follows:

Volunteer will never institute any action or suit at law or in equity against the Humane Society of Montgomery County, nor institute, prosecute or in any way aid, assist or participate, directly or indirectly in the institution or prosecution of any claim, demand, action or cause of action for damages costs, loss of services, expenses, or compensation for or on account of any damage, loss or injury either to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, past, present or future, arising out of the condition or operation of the Humane Society of Montgomery County or its facilities (including, but not limited to, any damage, loss or injury either to person or property, or both, resulting from contact with or the actions or conduct of any animal located at or in the custody or control of or in connection with the Humane Society of Montgomery County). The undersigned volunteer further hereby releases, demises, and discharges the Humane Society of Montgomery County and covenants and agrees to defend, indemnify and hold the Humane Society of Montgomery County harmless of and from any and all of the foregoing, including but not limited to actions, causes or actions, claims, demands, damages, suits, costs, expenses said volunteer has, had or may have for any reason or which may occur or arise by reason of volunteer's association, activity or work now, heretofore or hereafter at and/or with the Humane Society of Montgomery County.

This covenant and release shall inure to and for the benefit of the Humane Society of Montgomery County, its successors and assigns, officers, agents, director, employees, volunteers and representatives; and shall be binding on volunteer, volunteer's successors and assigns, spouse, family, heirs, executors, administrators and representatives.

This instrument reflects the entire covenant and release agreement and understanding of the parties, and no statements, promises or inducement made by or on behalf of the Humane Society of Montgomery County not contained herein shall be valid or biding.

The undersigned volunteer executes and delivers this release and covenant not to sue agreement and instrument in order to induce the Humane Society of Montgomery County to permit volunteer to perform service and work as an unpaid volunteer at an in connection with the non-profit activities of the Humane Society of Montgomery County.

The undersigned volunteer has carefully read and understands the foregoing, and has the right and wishes to execute this instrument as volunteer's free and willing act, and so acknowledges.
